
















FAULTY CABLE LET'S STAMP IT OUT

The Approved Cables Initiative seeks to:

- Eliminate non-approved, unsafe or counterfeit products from the UK supply chain.
- Eradicate manufacturers and distributors of non-approved, unsafe or counterfeit cable products.
- Stop importers deliberately under-specifying cable for their own profit.
- Lobby Government to make the sale and use of compliant, approved cable obligatory in the UK.
- Proactively investigate non-approved, unsafe or counterfeit cable products in the supply chain.

CABLE SAFETY CHECKLIST — SEE OVER FOR EXAMPLES

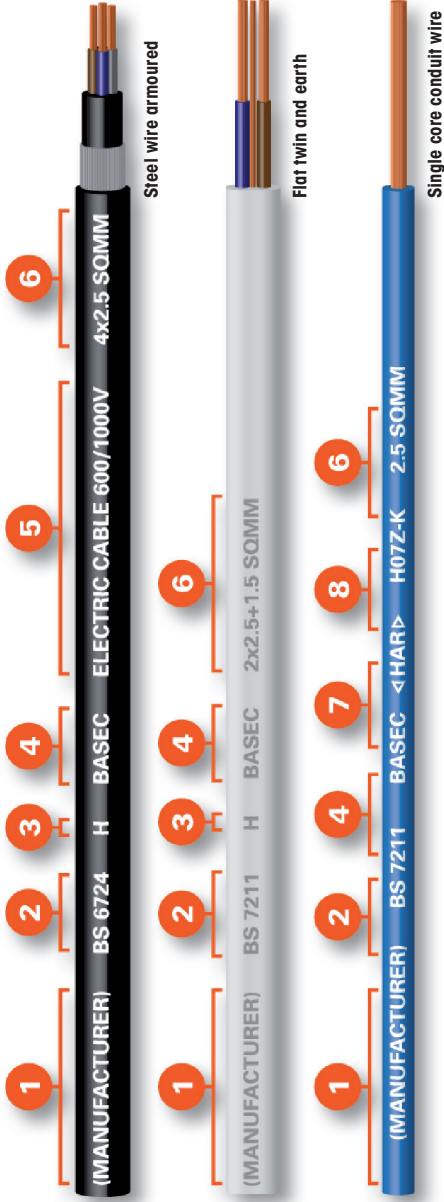
Cable is UNMARKED	
Cable is marked with MANUFACTURER'S NAME ¹ for traceability	
Cable has NO MANUFACTURER'S NAME marked ¹	
Cable has CORRECT BRITISH OR EUROPEAN ² STANDARD NUMBER	
Cable has NO BRITISH OR EUROPEAN STANDARD ² NUMBER	
Cable has THIRD PARTY APPROVAL (e.g. BASEC, HAR) ⁴ for independent assurance	
Cable has NO THIRD PARTY APPROVAL ⁴	
Cable marking has CORRECT NUMBER OF CORES ⁶ & CROSS SECTIONAL AREA	
Cable marking has INCORRECT NUMBER OF CORES & CROSS SECTIONAL AREA ⁶	
Cable has CORRECT VOLTAGE RATING marked ⁵	
Cable has INCORRECT VOLTAGE RATING marked ⁵	
Cable is CORRECTLY PACKAGED WITH MANUFACTURER'S TRACEABILITY INFORMATION ¹	
Cable is INCORRECTLY PACKAGED WITHOUT ANY MANUFACTURER'S TRACEABILITY INFORMATION ¹	
Cable CONFORMS TO THE DELIVERY NOTE AND TO THE ORDER PLACED	
Cable does not CONFORM TO THE DELIVERY NOTE AND TO THE ORDER PLACED

EXAMPLES OF CABLE MARKING

- 1 Manufacturer's name or trademark – required on all cables
- 2 British Standard number for the cable specification
- 3 Indicates that harmonised core colour scheme has been used
- 4 Approval body's registered certification trademark – required on all approved cables
- 5 Required marking for British Standard armoured cables
- 6 Number and nominal size of cable cores
- 7 Additional certification trade mark for certain cables approved under the pan-European HAR scheme
- 8 Harmonised code designation – European cable type code
